SECOND AMENDMENT TO AGREEMENT
BETWEEN THE
CITY OF YORBA LINDA
AND THE
COUNTY OF ORANGE

THIS SECOND AMENDMENT TO AGREEMENT is entered into this 26th day of December 2012, which date is enumerated for purposes of reference only, by and between the CITY OF YORBA LINDA, hereinafter referred to as "CITY" and the COUNTY OF ORANGE, a political subdivision of the State of California, hereinafter referred to as "COUNTY", to amend, effective upon signature of both parties, that certain Agreement between the parties dated the 17th day of July 2012, hereinafter referred to as the "Agreement".

WHEREAS Article A identifies May 3, 2013 as the commencement date for law enforcement services under the Agreement, unless an earlier commencement date is specified by written amendment; and

WHEREAS, Sub article B. 1. authorizes the SHERIFF, on behalf of the COUNTY and CITY's Manager, on behalf of CITY, to execute a written amendment to the Agreement to specify that contract law enforcement services will begin earlier than May 3, 2013.

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

1. The provision of full law enforcement services to the CITY under the Agreement shall commence January 5, 2013 at 00:00:01 hours.

2. CITY shall pay COUNTY the full cost of law enforcement services in accordance with PAYMENT Subsection G.4-c of the Agreement commencing January 5, 2013 through May 2, 2013.
